

Negotiation Notice

A resource authority holder may give an eligible claimant a negotiation notice prior to negotiating a conduct and compensation agreement or a deferral agreement. The notice must comply with the requirements of Chapter 3 (Land Access) of the *Mineral and Energy Resources (Common Provisions) Act 2014.* This is a template negotiation notice – it is not an approved form. After giving the negotiation notice, the resource authority holder and the eligible claimant (the **parties**) must use all reasonable endeavours to negotiate a conduct and compensation agreement or a deferral agreement.
