What to use this form for: This form should be used to make an objection in relation to an application for grant of a mining lease under section 260 of the *Mineral Resources Act 1989*.

Giving the objection to the applicant: you must also provide a copy to the mining lease applicant. To send the objection using email you must only use the email address (if any) specified in the mining lease notice. If an email address is not specified, then the objection must be sent to the postal address in the mining lease notice.

Date and time for lodgement: Regardless of how the objection is lodged, it **must** be received by the relevant Assessment Hub **before 4:30pm AEST on the last objection day.** Objections lodged after 4:30pm AEST will not be properly made and cannot be accepted. If lodging this objection in person, business hours are 8.30am to 4.30pm AEST, Monday to Friday (excluding public holidays).

Further information for objectors

Properly made objection

A properly made objection to an application for the grant of a mining lease is one that:

- is lodged with the department on or before 4:30pm AEST on the last objection day for the application;
- is in the approved form (this form);
- states the grounds of the objection and the facts and circumstances relied on by the objector in support of those grounds;
- has been served a copy of the objection to the applicant on or before 4:30pm AEST on the last objection day for the application; and
- is an objection lodged under section 260 Mineral Resources Act 1989 that has not been withdrawn.

Withdrawing an objection

You can withdraw this objection by giving written notice of the withdrawal to:

- a) the chief executive; and
- b) if the objection has been referred to the Land Court
 - i. the Land Court; and
 - ii. the applicant

A withdrawal of an objection can not be revoked.
